

SPECIAL EVENTS AND TROPHIES

During the over 100 year history of Twa Days, many trophies have been handed out for a variety of contests and competitions. To help celebrate our $105^{\text{\tiny TH}}$ tournament, we are going to present awards for the following competitions. We hope that this adds to your enjoyment of Twa Days.

PUIR PUTTER TROPHY

This trophy will be presented to the player who records the best gross score on the putting course around the Putting Green. This event will be open for play on Friday, July 20 from 5:00 pm to 8:30 pm. Ties will be broken using a playoff on Saturday if needed.

AUCHTERLONIE TROPHY

This award will be presented to the team accumulating the greatest number of points during their five matches at Twa Days.

LAIGH AND LANG TROPHY

This award will be presented to the team that has the lowest better-ball score for the final 9-hole match. Prizes will be awarded for both gross and net scores on the front nine and back nine. All ties will be broken using the Glen View Rule.

FLIGHT TROPHIES & OVERALL CHAMPION/RUNNER-UP

Awards will be presented to the team that accumulates the most points in each flight. Ties for 1^{st} and 2^{ND} place in the overall playoff will be broken using a sudden-death playoff and awards presented to the Overall Champion and Overall Runner-Up. Second place teams in a flight whose flight winner places in the top two in the medal playoff move up in their flight, thereby creating an incentive to cheer on their former adversaries!



EVENT FORMAT & SUMMARY OF RULES

- 1. U.S.G.A. Rules shall govern all play, except where local rules apply. Local rules are printed on the back of the scorecard.
- 2. 14 club rule will be in effect.
- 3. The field is broken into flights of six teams. Each team plays a nine hole, better ball match against the other teams in its flight (27 holes on Friday and 18 holes on Saturday) with strokes determined based on the Essex System. This means strokes will be taken off the low handicap in each foursome (at 90% of handicap) with strokes falling according to their handicap ranking on the scorecard. Handicaps are determined using the index shown on the July 1 handicap change.
- 4. Ten points will be awarded for each match as follows:
 - 1 point for winning a hole
 - ½ point for tying a hole
 - 1 point for winning a match
 - ½ point for tying a match

The team earning the most points is the flight winner and qualifies to compete in the four hole, medal play-off on holes 10, 13, (165 yards par 3) 17 and 18. In the playoff, both balls count on each hole for the team total. Two wild card teams will also qualify for the play-off. The wild card teams consist of the team that accumulates the most overall points on Saturday without winning their flight, and the team that accumulates the most total points without winning their flight.

- 5. Ties: Ties for first and second place overall will be broken using a sudden-death playoff. Second place teams in a flight whose flight winner places in the top two in medal play competition move up in their flight, thereby creating an incentive to cheer on their former adversaries!
- 6. Slow Play: Teams who lose their position in the field will be warned first, and if their position does not improve, they will be assessed a loss of hole penalty. Continued loss of position could result in disqualification.
- 7. Late Start Rule: Any team's failure to arrive on their designated tee at their designated time will be penalized two strokes. If the team has not arrived within five minutes after their designated time, the team will be disqualified for match.
- 8. In the event of any questions regarding rules for the Tournament, Kyle Bauer will serve as the Rules Committee.
